

User's consent for processing personal data

The subject of personal data (hereinafter referred to as the User, Customer), visiting the website of ESC LLC at https://esc.group (hereinafter referred to as the Site), and filling in and sending the feedback form on the Site page https://esc.group/contacts or the purchase order form on the Site page https://esc. group/catalog, gives its consent (hereinafter referred to as the Consent) to ESC LLC (TIN 9701082150, address: 105082, Moscow, Spartakovskaya Square, 14, building 4, room 1 (hereinafter referred to as the Company), to process its personal data.

1. List of personal data for the processing of which consent is given:

- name (as well as surname and patronymic, if provided by the User);
- electronic address (e-mail address);
- User's telephone number;
- the User's address, if the User has provided such data;
- system information, data from the User's browser;
- cookie files, IP addresses of the user;
- information about the types of browsers installed on the user's computer;
- information about the languages installed and used on the User's devices;
- geographical location of the user;
- the number of visits to the Site and the pages viewed by the User;
- the duration of the User's stay on the website.

2. Purposes of personal data processing:

- processing of orders, requests of Users, including those representing the interests of legal entities;
- identification of parties to agreements, contracts and agreements that the User has concluded or will conclude with the Company;
- transfer of the User's personal data to third parties necessary for the Company to fulfill its obligations under the terms of contracts concluded or entered into by the User with the Company;
- communicate with the User, including sending responses, price lists, quotations, notifications and information regarding the delivery of goods to the User;
- analyzing the User's actions on the Site.
- 3. During the processing of personal data, the following actions will be performed: collection, recording, storage, clarification (update, modification), extraction, use (for the purposes specified in clause 2), blocking, deletion, destruction.
 - 4. This Consent shall be valid indefinitely (or until the day of withdrawal of the Consent).
- 5. Processing of personal data may be terminated at the request of the User. The consent may be withdrawn by the User or its authorized representative by sending a written application to the address of ESC LLC specified at the beginning of this Consent, or sent via the feedback form on the Site at https://esc.group/contacts.
- 6. In case the User or his/her representative withdraws the Consent, the Company is entitled to continue processing of its personal data only if there are grounds provided by the Federal Law No. 152-FZ "On Personal Data".
- 7. The User agrees that the personal data provided by him/her on the basis of this Consent shall be processed by the Company until the purposes of processing such data, specified in clause 2 of this Consent, are achieved, or until the revocation of the Consent to process personal data, whichever comes first.
- 8. The Company makes every effort to ensure the confidentiality of the data sent by the User of the Site through the feedback form or the order form, as well as the cookies used, for the entire period of the User's use of the Site.
